- the University of Punjab wishes to strengthen the Portuguese language status through the Portuguese Studies development;

 the vocation of Camões. LP., is to propose and execute the teaching and divulgation policy of the Porcuguese language and culture abroad.

The Signatories decide to celebrate the present Protocol of Cooperation under the terms and conditions as described below.

Clause 1

(Purpose)

The purpose of this Protocol of Cooperation is to stablish the conditions of the allocation of financial support of the Camões, I.P. for activities in the environment of dissemination of Portuguese language and culture.

Clause 2

(Camões, I.P. dutles)

- In the scope of the present Protocol of Cooperation, the Camões, I.P., is committed to:
 - Support scientific and pedagogically the Portuguese teacher of University of Funjab.
 - b) Follow-up and monitor the execution of this Protocol of Cooperation:
 - c) Transfer to the Embassy of Portugal in Islamabad, the amount set out in the Clause 4 of this Protocol of Cooperation to support the activities promoted by the University of Punjab which uphold the spirit of this Protocol;
 - d) Contribute to the consolidation of the course by offering educational materials in opportune occasions, in order to enrich the study resources.
- 2. In the case of Camões, I.P. approve general rules regarding the visibility and divulgation of the respective supports, they shall be communicated to the University of Punjab, in order to assess the possibility of its application to the executed actions or to execute, under the present Protocol of Cooperation.

 The agreed financial support of Camões, I.P. in the present Protocol of Cooperation will depend of the budgetary availability of Camões, I.P. in each year of its effect.

Clause 3

(University of Punjab duties)

In the scope of the present Protocol of Cooperation the University of Punjab is committed to:

- a) Support the hiring of a teacher chosen, by common agreement, by the Signatories, namely by financial contribution;
- Ensure the necessary conditions so that the teachers may develop their activities in accordance with the stablished Protocol Cooperation;
- c) Execute the Protocol of Cooperation in accordance with the set deadlines and conditions;
- d) Communicate to Camões, LP, any change or occurrence that may jeopardize the assumptions in relation to the Protocol of Cooperation implementation;
- e) Provide to Camões, I.P. the required information and documents in relation to the execution of Protocol of Cooperation;
- f) submit to Cambes, i.P., in November, the Activity Plan for the next year, which should be coordinated with the Embassy of Portugal in Islamabad;
- g) The University is responsible for ensuring the visibility and the necessary divulgation of the support provided by Cambes, in the scope of this Protocol of Cooperation, maxing explicit reference to Cambes, IP., namely through the inclusion of the Cambes, I.P. logotype in the cover and/ or baseboard of folders, textbooks or in any other analogue materia, as well as in brochures or posters;;
- h) For the purpose of the previous point, the Cambes, I.P. informs that their logotype is available in https://www.instituto-camoes.pt/quam-somos/logotipos-descarregar

Clause 4

(Financial Support)

- The financial support, referred in the point c) of the first subparagraph of the Clause 2, assigned by Cambes, 1.P., shall be the maximum amount of € 2,000.00 (two thousand euros);
- 2 The financial support, referred in the previous subparagraph, is exclusively destined to support the activities in the environment of dissemination of Portuguese language and culture.

Clause 5

(Representative for supervising the cooperation)

For the purpose of supervising the cooperation, under the terms of the present Protocol, the Signatories nominate the following as theirs representatives:

- a) By Camões, I.P. The Director of Language and Culture Services;
- b) By University of Punjab (designate the posti.

Clause 6

(Changes to the protocol)

Any changes or addendum to this Protocol of Cooperation shall be decided, by mutual agreement, between the Signatories and object of a written document, signed by the Signatories legal representatives.

Clause 7

(Termination)

The present Protocol of Cooperation may be withcrawn by any of the Signatories, by reasons duly substantiated, since that such intention is communicated to the other signatory, by writing notice, with a minimum advance of 120 days.

(Settlement of Disputes)

If any dispute arises in relation to the implementation or interpretation of this Protocol of Cooperation, the Signatories shall be consulted, in order to solve the dispute under the principles that guided its celebration.

Clause 9

(Effects Production)

The present Protocol of Cooperation shall come into effect from the beginning of 2018/2019 until the academic year 2020/2021, may be renewed for equal periods of three years, if this is in the interest of the Signatories.
