

MEMORANDUM OF UNDERSTANDING

between



University of the Punjab, Pakistan & Jiangsu Normal University, China

Premise

Jiangsu Normal University, China and University of the Punjab, Lahore, further referred to as Parties, seeking to establish and develop institutional ties, in particular, to develop cooperation in teaching and research programmes, agree as follows:

Art. 1

The scope of the MoU is:

- 1. to develop academic exchanges between the two institutions
- 2. to organize exchange of faculty and students

Art. 2

In order to implement the above mentioned objectives, subject to the availability of funds and mutual consent, Jiangsu Normal University, China and University of the Punjab agree to conduct joint collaborative programmes in the following fields:

- Exchange of faculty members and postgraduate students between the two universities. Both universities will offer scholarships for the students from each university.
- Cooperation in academic projects centered in one or both of the two institutions
- Participation in and organization of joint research seminars and academic meetings; exchange of academic materials; information and documents
- To achieve the aim of joint research programmes, to set up a branch of the Institute of Belt and Road, Jiangsu Normal University at Pakistan Study Centre, University of the Punjab, Lahore if possible, with the financial support of Jiangsu Normal University.

Art. 3

Financial terms and conditions of activities for the joint programmes concerning academic exchanges between the institutions will be established by mutual agreement. Efforts will be made by the Parties to secure funding for the implementation of such programmes.

This agreement shall become effective on the date of its signing and will continue thereafter for two years subject to revision or modification by mutual agreement and unless terminated by either of the parties hereto. Termination by one institution shall be effected by giving the other institution at least 90 (ninety) days advance written notice of its intention to terminate, but any students who have commenced at either university at the date of termination may complete their course of study. Termination shall be without penalty.

Both the institutions agree to the above in principle subject to the completion of such other formalities required by the university bodies including the approval of the respective Governments.
