## MEMORANDUM OF UNDERSTANDING

**THIS MEMORANDUM OF UNDERSTANDING** (hereinafter referred to as the “MoU”) is made and entered into on 29<sup>th</sup> March 2017 by and between:

**Amanah Halal Research Centre (Amanah HRC)**

AND

**Institute of Agricultural Sciences (IAGS), University of the Punjab**

The above-mentioned parties are hereinafter referred to collectively as “Parties” and individually as “Party”.

### 1. PURPOSE AND SCOPE

The purpose of this MoU is to provide a general framework for facilitating collaboration and cooperation between the Parties in the following points:

- This strategic partnership agreement would be for 4 years but with mutual consent; both organizations can renew it for further time period.
- Amanah HRC will annually provide 1 complimentary pass to IAGS to participate in international conferences organized by solely Amanah HRC. Similarly, IAGS will provide 1 complimentary pass to Amanah HRC team members for their local and international events such as conferences and seminars *etc.* Both parties will also provide complementary stall/table top to each other during their conferences and events.
- IAGS will use logo of Amanah HRC on different events, training workshops and research symposiums as Strategic Partner and Amanah HRC will use logo of IAGS on its websites and its marketing material as Strategic Partner.
- Amanah HRC and IAGS would jointly conduct wherever possible trainings and workshops for the faculty and students of IAGS (further details i.e. logistics *etc.* would be discussed at the time of event).





- Depending on the market need, both organizations will share resources such as trainers and intellectual property for specific events i.e. workshops, conferences *etc*, but mutual consent will be required before any such event.
- Both parties can display their logos in the websites section "Strategic Partners".
- Amanah HRC will recommend its local e-learning students to enrol in IAGS for relevant programs i.e. Food/Nutrition/Halal Sciences *etc*. IAGS will facilitate Amanah HRC to pass on information in the form of flyers *etc* for e-learning courses offered by Amanah HRC to the students and faculty *etc*.
- Both parties will share their experiences in organizing different events/activities related to Food and Halal, locally and internationally.
- Amanah HRC will promote events of IAGS through online and e-mail shots. In return IAGS will provide table top/stall/booth as complimentary to Amanah HRC.
