



**Memorandum of Understanding**  
*between*  
**UNIVERSITY OF THE PUNJAB, LAHORE**  
*and*  
**MAJLIS TARRAQI-E-ADAB, LAHORE**

This Memorandum is made on **Thursday, 8<sup>th</sup> Day of April, 2021** between the University of the Punjab, Lahore (herein after called the **PU**) on the one part and the Majlis Tarraqi-e-Adab, Lahore (herein after called the **Majlis**) on the other part.

UNIVERSITY OF THE PUNJAB was established in 1882, is the largest and historic University in the country with its valuable educational and research activities. The Main Library of the Punjab University has a rich treasure trove of rare books and manuscripts.

MAJLIS TARRAQI-E-ADAB a literary institution was established in 1954 under the administration of the Punjab Government for the promotion of URDU language and literature. Under the auspices of the Majlis, more than 500 high quality books on various topics have been published. For the promotion of Urdu Literature, the Majlis wants to translate and publish the rare books and manuscripts available in the Library of the Punjab University.

It is intention of both parties to develop the partnership to exchange the manuscripts and rare books. This agreement is made between PU and MAJLIS establishing the basis for their further cooperation by entering into this MOU bearing the following provisions:

- Dr. Jabeen shall visit P.U. library and her salary will be paid by the Majlis.
- Dr. Jabeen is allowed to scan and photocopy manuscripts as well as rare books.
- In return, PU is allowed to use Majlis books.
- The cost of scanning and photocopy of the required books by PU will be borne by the Majlis.
- The PU will be responsible for the cost of scanning and printing of required books for Majlis.
- This MOU shall take effect for a period of five (5) years and may be automatically renewed for successive five years unless either party gives the other written notice of its desire to terminate or to revise the MOU twelve months prior to the expiry of this MOU.
- Both parties will mutually assist and cooperate to ensure that the activities to be carried out under this MOU comply with all applicable laws.


